We look forward to welcoming you at this special celebratory event on Wednesday 5 October 2022, and to your participation and continued support for another 25 years!

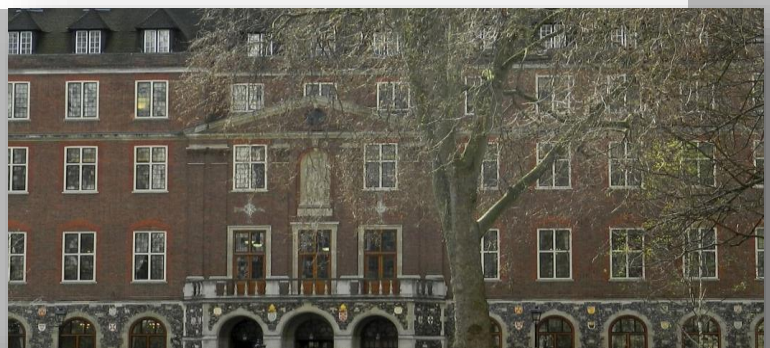
