Co-Sourcing and the tax audit – Fran Wood, Operational Audit Manager, Allianz and John Cannon, Senior Manager, EY

Co-sourcing with EY, Fran has just completed an audit of direct and indirect tax processes and controls and will share a practitioner's view on tax risks and controls, tax audit approach and methodology, and the hidden risks! The session also provides details of a practical approach to co-sourcing the tax audit and some lessons learned with this approach.

Reconciling technical innovation with data protection – Ian Stephens, Partner, CMS Cameron McKenna LLP

The European Commission plans to reform European Union (EU) data protection law, harmonising data protection procedures and enforcement across the EU, including by replacing the existing Directive with a new General Data Protection Regulation (GDPR). The scale of data sharing and collecting has increased dramatically, transforming both the economy and social life and bringing new challenges for the protection of personal data. Technology such as cloud computing, the internet of things, social networking platforms and mobile apps enable both private companies and public authorities to make use of personal data on an unprecedented scale. Individuals increasingly make personal information available publicly and globally. Ian will give an insight into the new requirements and the emerging risk associated with technological innovation and data protection.
